As per today there are about 500 children hosted in the Fostering Houses of the Kimbondo Paediatric Hospital.

Despite of difficulties and of the hard work needed, Kimbondo welcomes all the children in need, none excluded.

How to activate a SAD (Child Sponsorship) ?

The 500 children of Kimbondo are hosted in several Foster Houses , into the Kimbondo Paediatric Hospital compound. You can help them either sponsoring one of the Foster Homes (**Collective Adoption – Collective SAD**) or, if you wish, one of its children that will become your direct sponsorship (**Direct Sponsorship - Individual SAD**). You can also choose to sponsor a child or a young adult funding his/her secondary or professional education and to help him/her to get a job (**Opportunities Project**). Even when you will choose a direct sponsorship, your support will always fund the needs of the entire Foster House since all the available resourced are always equally shared among all the children, as it happens in a large family. SAD is a yearly commitment and will be renewed automatically for one more year, if not cancelled. The sponsorship can be interrupted but you will need to let AGAPE Onlus know with early advice, to allow find another sponsor.

Child Sponsorship

You need to fill and send an application sheet that can be found at www.agapeonlus.it, taking care to specify the kind of support chosen as well as your personal data and the modality of the yearly payment. At that time you will also choose the Foster House you want to support:



Casa Patrick (code: CP)

(Collective Sponsorship or Individual SAD)

Neonatologia (code: NE)

(Collective Sponsorship or Individual SAD)

Casa Betty (code: CB)

(Collective Sponsorship only)

Nzimbi (code: NZ)

(Collective Sponsorship only)

(Collective Sponsorship only)



Which information will be sent to the sponsor ?

The sponsor will receive the photo of the child (children) hosted in the Fostering House supported by the sponsorship, together with a set of information about the House. The information is updated at least once per year.



Is my contribution going to pay also other costs?

100% of your help will be used according to your choice. This is possible because Agape ONLUS use the yearly support fee of the members, the free optional fee of the Italian sponsors and the targeted donations to cover all the handing costs.





What is the yearly cost of the Sponsorship?

1) Collective Adoption (Collective SAD) You can choose the yearly amount you wish to give, indicating such amount the Application Sheet (code: COLL)

2) Direct Sponsorship (Individual SAD)

The yearly cost of one sponsorship (overall costs of the Foster House divided the number of children hosted) is nowadays € 780. You can either choose to fund the entire yearly cost of one child or share such cost with other sponsors.

These are the options:

- € 780,00 code: SAD 1 for the full sponsorship
- € 130,00 code: SAD 2 for medical care and clothing needs
- € 260,00 code: SAD 3 for food and education
- € 390,00 code: SAD 4 for food, education, clothing and medical care

If you wish to sponsor a child or a young adult funding his/her secondary or higher education studies (college or professional studies) you can fund the

3) OPPORTUNITIES PROJECT with a yearly amount of your choice, starting from € 100 (code: OPP)

We need to plan for the future: your support plan can be cancelled but, if this is not the case, it will be important to let us know when can we count on it and make sure it happens timely!

Can I get a Tax credit for my sponsorship?

It depends on the country. In Italy AGAPE is listed among the ONLUS (Organizzazione Non Lucrativa di Utilità Sociale) hence your sponsorship (if paid by bank wire or thought a o c/c postale) can be used as tax credit simply keeping a copy of the payment.

In other countries you should check the country's fiscal law. AGAPE will be available to issue, upon request, a suitable declaration for the purpose.
